Agreement

1. In consideration of Barter Vista Pte Ltd ("Barter Vista") providing administrative and trade services to member, the member agrees to pay Barter Vista the following fees :

a) i) Lifetime Membership : **S\$400** (one time only) - **Non-Refundable** or by instalment at **S\$200 x 2 months**
ii) Administration Fee : **S\$15 payable monthly after 1st year** ; **S\$15 payable monthly after 1st year**
b) i) Lifetime Membership : **S\$800** (one time only) - **Non-Refundable** or by instalment at **S\$400 x 2 months**
ii) Administration Fee : **Nil**

c) Transaction Fee Vista Trade Credit (VTC) component : **5% Cash** on all purchase and sales made by member through the platform.
d) Transaction Fee (if any Cash component): **8% Cash** of the cash component of the sale transaction made by member through the platform.

2. The Applicant confirms that he has read and understands and agrees to abide by the terms and conditions herein, and the provisions and rules contained in *Terms & Conditions* attached.

3. The Applicant agrees and acknowledges that the *Terms of Use* form part of the membership agreement with Barter Vista, and governs the trading transactions with other members of the platform.

4. Nothing in this agreement shall create a partnership or agency between Barter Vista and the Applicant.

5. The Applicant represents and warrants to Barter Vista that the applicant:

- a) Or its partners is not an un-discharged bankrupt, is not insolvent or has not committed an act of insolvency or has not been served with a winding up order in Singapore or elsewhere;
- b) has the legal capacity and authority to enter into this agreement;
- c) agrees not to charge more than the prevailing price for goods and services they supply;
- d) agrees to treat fellow Exchange members as equal to cash paying clients, and will ensure they receive prompt and response and service;
- e) acknowledge that it not always possible for fellow Barter Vista members to sell their product and service on barter or on the platform.

6. The Applicant agrees that neither Barter Vista nor any of its directors, officers, servants, agents and contractors either for themselves or on behalf of Barter Vista Pte Ltd give any warranty and/or guarantee to the Applicant relating to the performance, turnover or volume of trading or transaction or the profits which the Applicant may generate or secure as a trader of Barter Vista.

7. All liability of any kind to Barter Vista from any Member with respect to the services provided by it or other Barter Vista Members is excluded to the fullest extent permitted by Singapore law.

8. The Applicant agrees that should they have a deficit of Vista Trade Credits (VTCs) and decide to leave the platform, he/she is liable to repay the Singapore Dollars equivalent of their outstanding VTCs to Barter Vista.
